VOTING PROCEDURE

The Company has appointed Boardroom as the Poll Administrator to conduct the poll by way of electronic voting ("e-Voting") and Boardroom Corporate Services Sdn Bhd as the Scrutineers to verify the poll results.
- During the virtual AGM, the Chairman will invite the Poll Administrator to brief on the e-Voting housekeeping rules. The voting session will commence from 2.30 p.m. on Monday, 29 August 2022 until such time when the Chairman announces the closure of the poll for each Resolution.
- E-Voting for each of the resolutions as set out in the Notice of 57th AGM will take place upon the conclusion of the deliberations or Questions and Answers session of all business transacted at the AGM.
- The Chairman will declare the result of the polling upon completion of the polling for all the resolutions.
