MODE OF MEETING

The 58th AGM of Panasonic Manufacturing Malaysia Berhad (“the Company”) will be conducted **entirely on a virtual basis through live webcast and online remote voting using the Remote Participation and Voting facilities**. This is in line with the *Guidance and FAQs on the Conduct of General Meetings for Listed Issuers* issued by the Securities Commission Malaysia.

Kindly note that it is your responsibility to ensure the stability of the internet connectivity throughout of the AGM is maintained as the quality of the live webcast and online remote voting are dependent on the bandwidth and stability of the internet connection of the participants.

The Broadcast Venue mentioned above is strictly for the purpose of complying with Section 327(2) of the Companies Act 2016 which stipulates that the Chairman of the meeting shall be at the main venue of the 58th AGM and in accordance with Clause 86 of the Company’s Constitution which allows a meeting of members to be held at more than one venue, using any technology or method that enables the members of the Company to participate and to exercise the members’ right to speak and vote at the meeting. **No Shareholders/Proxies/Corporate Representatives** from the public should be physically present nor admitted at the Broadcast Venue on the day of the AGM.

ENTITLEMENT TO PARTICIPATE AND VOTE

In respect of deposited securities, only shareholders whose names appear on the Record of Depositors on 23 August 2023 (General Meeting Record of Depositors) shall be eligible to attend the AGM and/or appoint proxy(ies) to attend, participate and/or vote on his/her behalf.

PROXY AND FORM OF PROXY

In accordance to the Company’s Constitution, Shareholders are entitled to vote at the AGM either personally, electronically or by Proxy. As the 58th AGM will be conducted via a virtual meeting, a shareholder who is unable to participate in the AGM is encouraged to appoint the Chairman of the Meeting as his/her proxy and indicate the voting instructions in the Form of Proxy.

The appointment of Proxy may be made in hard copy or electronic form as follows:

In hard copy

Shareholders may deposit the duly executed Form of Proxy at the office of our Share Registrar, Boardroom Share Registrars Sdn. Bhd. no later than 10.00 a.m. on Monday, 28 August 2023.

REVOCAION OF PROXY

VOTING PROCEDURE

- In accordance with Paragraph 8.29A(1) of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, the voting at the virtual AGM will be conducted by poll. The Company has appointed Boardroom as the Poll Administrator to conduct the poll by way of electronic voting (“e-Voting”) and SKY Corporate Services Sdn Bhd as the Scrutineers to verify the poll results.
- During the virtual AGM, the Chairman will invite the Poll Administrator to brief on the e-Voting housekeeping rules. The voting session will commence from 10.00 a.m. on Wednesday, 30 August 2023 until such time when the Chairman announces the closure of the poll for each Resolution.
- E-Voting for each of the resolutions as set out in the Notice of 58th AGM will take place upon the conclusion of the deliberations or Questions and Answers session of all business transacted at the AGM.
- The Chairman will declare the result of the polling upon completion of the polling for all the resolutions.

DISTRIBUTION OF VOUCHER

There will be no distribution of voucher for shareholders/proxies who participate in the AGM.
