#### PROXY AND FORM OF PROXY

In accordance to the Company's Constitution, Shareholders are entitled to vote at the AGM either personally, electronically or by Proxy. As the 58<sup>th</sup> AGM will be conducted via a virtual meeting, a shareholder who is unable to participate in the AGM is encouraged to appoint the Chairman of the Meeting as his/her proxy and indicate the voting instructions in the Form of Proxy.

## **VOTING PROCEDURE**

- In accordance with Paragraph 8.29A(1) of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad, the voting at the virtual AGM will be conducted by poll. The Company has appointed Boardroom as the Poll Administrator to conduct the poll by way of electronic voting ("e-Voting") and SKY Corporate Services Sdn Bhd as the Scrutineers to verify the poll results.
- During the virtual AGM, the Chairman will invite the Poll Administrator to brief on the e-Voting housekeeping rules. The voting session will commence from 10.00 a.m. on Wednesday, 30 August 2023 until such time when the Chairman announces the closure of the poll for each Resolution.
- E-Voting for each of the resolutions as set out in the Notice of 58<sup>th</sup> AGM will take place upon the conclusion of the deliberations or Questions and Answers session of all business transacted at the AGM.
- The Chairman will declare the result of the polling upon completion of the polling for all the resolutions.
